Since 1993, the Apprentice Employment Network WA (AEN WA) and its Committee of Management, have demonstrated a long history of regular engagement with senior levels of Government, industry organisations and associations, employers, schools and registered training organisations, with responsibility for skills training, development and employment through apprenticeships and traineeships.

AEN WA regularly meets with:
